**3. REGISTERED OFFICE OF THE TRUST: -**

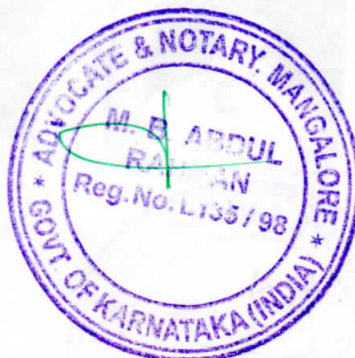

12. To help widows, orphans, lunatics, indigent persons and the victims of various social evils of the society, and to give relief to the poor and distressed disabled destitute etc.,
13. To build, equip, take over conduct, maintain and grant aids to dispensaries maternity homes, hospitals, lunatics asylums or any Other institutions of the like nature.
14. To erect and maintain dharmasalas, poorhouse, public parks, etc.
15. To carry out all such acts and things that are incidental or necessary for the promotion of the aforementioned objects with special reference to weaker section people and others in general.
16. To promote the well being of humanity by establishing or assisting the formation of, aiding or humanitarian institutions and of start, encourage, promote or support the Social and economic interest of the people of the world. To unite them in such a manner as may best to ensure the attainments of proper shelter, food and clothing as well as and happiness of the humanity at large.
17. To subscribe to such other charitable objects as the trustees may deem proper provided, however that the donees in such cases are recognized under section 11,12,13 and 80 G of the Income Tax Act, 1961 as amended from time to time and / or for such purposes and for such places of archeological or artistic importance as are notified under 80G (2) of the Income Tax Act, 1961 as amended from time to time.
18. To associate and collaborate with any organization, Government agencies including international organization in the activities for fulfilling objects of the Trust.
19. To accept donations, grants assistance, subsidy, accept reimbursement or any amount from individuals, government and any organizations including NRI International organizations.





**6. NATURE OF THE TRUST:-**

This Trust shall be Irrecoverable and a Public Charitable Trust and the properties, monies and the income thereof shall be solely applied towards the promotion of the objects for which the trust is established and no portion thereof shall be distributed as profit among the trustees and also the authors of the trust shall not utilize any money for the purpose other than to achieve objects of the trust. **7. TRUSTEES AND THEIR TENURE OF OFFICE:-**

5. Dr. Natasha Baig

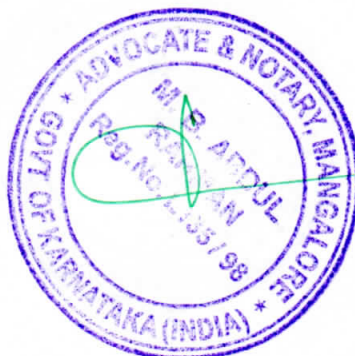

**8. APPLICATION OF TRUST PROPERTY AND FUNDS:**

- a. All properties of the Trust including the corpus, the addition and accretion thereto and the income there from shall be utilized for all or any purposes of the Trust as set out supra and in such manner and to such extent as the trustees may from time to time to determine.

b. All the moneys, which are immediately required, shall be invested in conformity with the provisions of the action 11,12 and 13 of the Income Tax Act, 1961.

**9. THE POWER OF TRUSTEES:**

The Trustees shall have full power and authority to administer the trust, its properties and affairs and to all such acts, deeds and things as are calculated to fulfill the objects for which the Trust is established,

Without prejudice to the generality of the forgoing, the Trustee shall have the following powers for purpose of this Trust.

1. To raise funds by contribution, donations from the individual company, public or from any other source for the benefits of the Trust or from the government agencies, local bodies, co-operative institutions, banks/state finance corporation, individual or from other private sources etc.

2. To acquire by purchase, grant, gift, exchange lease, higher or otherwise lands, building stocks, shares, securities, movable properties of every other descriptions.

3. To sell, mortgage, grant or lease higher and otherwise disposes all Properties of every other description.

4. To enter into all contracts on behalf of the trust.

5. To borrow money with or without security and to repay the same.

6. To open accounts in banks and provide for its operation by secretary and treasurer jointly, as may be decided upon by the board of Trustees from time to time.

7. To receive, collect and enforce recovery of all moneys due or payable to the trust and to grant necessary receipts and discharge therefore.

8. To appoint, terminate, suspend and otherwise deal with the staff.

9. To appear and represent before courts, tribunals, public officers etc, if necessary.

10. To institute prosecute and defend all suits and other legal proceedings.





11. To incur all necessary expenses in connection with the Trust and its management.
12. To make rules of the Trust.
13. To amend rules and regulations.
14. To enroll patrons, nominated trustees or in such other capacities as the board of the trustees may deem fit and to frame rules for enrollment and other matters relating to such position.
15. To pay out the trust funds, salary wages, rent for buildings, maintenance etc. relating to the trust and its activities or its other affairs for the management of the Trust.
16. To appoint committees, sub-committees from outsiders and/ among the members of the board and assign duties and seek suggestions for the purpose of working of the Trust and frame such rules and regulations for the management and administration of the trust and institutions as the board of the trustee may think fit and and to alter or vary the same from time to time and to make new rules and regulations which shall not be inconsistent with the terms of these presents. The board trustees shall be entitled to frame constitute and regulate the procedure of such committees.
17. The powers enumerated in these presents shall be exercised by the board of trustees subject to Their satisfying the conditions laid down under section 11,12,13 and 80(G) of the Income Tax act, 1961 as amended from time to time so that the income of the trust will be exempt from the income tax for each and every assessment year.
18. The powers vested in the board of trustees shall be exercised according to the decision of majority of the members of the board of trustees and by way of resolution passed whether by circulation by the meeting of the board of trustees.
19. To prepare and approve the budget.
20. The day-to-day administration of the affairs of the trust is vested with the board of trustees.

21. The trustees have power to permit the use of movable or immovable property and assets of the trust by institutions whose objects are similar to those of this trust.
22. To acquire by lease, purchase, gift, mortgage, license as beneficially in any other trust or otherwise, lands, properties, machinery etc. from the government or semi-government departments, trusts, corporation institutions and societies as well as individuals to sell, alienate gift, lease mortgage or in any other legal manner to transfer properties belonging to the trust and also to give the same on lease or license for the furtherance of the objects of the Trust.
23. To raise secured or unsecured loans from any other scheduled banks, financial institutions or firms or individuals as and when necessary for furthering the objects of the trust. For this purpose the board of trustees shall have the power to secure the assets and properties of the trust to the lending institutions or persons.
24. To receive voluntary donation in cash and in kind from individuals, institutions, and companies for the purpose of carrying out of the objects of the trust.
25. To open a Bank Account in any Schedule Bank including any co-operative Bank in the name of the Trust and operate the name in accordance with the resolution of Board of Trustees.
26. The Board of Trustees shall have power to invest the funds of the Trust in such manner as deemed for Trust subject to provision of section 11,12,13 of the Income Tax Act, 1961.






**10. BOARD OF TRUSTEES MEETING:**

1. Notice of every Board of Trustees meeting specifying the date hours, and place of the meetings with the agenda shall be sent to the Trustees at least 15 days before the date fixed for the meeting by circulating the meeting notices or by means of post.

**12. VACANCY OF THE TRUST:-**

The Board of Trustees has authority to co-opt any other Trustees with the consent of the majority of Trustees in the vacancy caused subject to the provisions of clause 7. The trustees so appointed should hold the office during the unexpired period of the previous trustees in whose places he co-opted.

**13. ELECTION OF THE PRESIDENT, VICE PRESIDENT, SECRETARY & TREASURER:-**

The trustees shall elect from among them a President, a Vice President, a Secretary and Treasurer who shall hold office for a period of Three years or until another persons elected to that post and they shall perform such duties as may be assigned to them by the Board of Trustees. In case, number of trustees is only two one shall be the President and another shall be Secretary. The Secretary shall perform the duties of both Secretary and Treasurer.

**14. DUTIES AND RESPONSIBILITIES OF BOARD OF TRUSTEES:-**

**1. PRESIDENT AND HIS POWERS:**

- a. The President shall be in over all in charge of the Management of the Trust.
- b. He shall fully supervise and manage the activities and inspect the activities particularly and cause to be inspected the place, of activities and business.
- c. He shall preside over all meetings of the Governing Body and Sub Committees. At meetings of the President shall have power to case a casting vote.
- d. He shall recommend top secretary to suspend, remove any staff member for the reason of indiscipline, misbehavior or misappropriation of funds or negligence of duties etc subject to ratification of government body.

**17. MAINTENANCE OF ACCOUNTS AND AUDIT: -**

The trustees shall maintain true and correct accounts of the Trust and correct record of their deliberation. The qualified auditors under Companies Act of 1956, every year and accounts to be prepared by Trustees, shall audit the accounts of the Trust.

**18. INVESTMENT CLAUSE:-**

The funds of the Trust shall be invested in the modes specified under the provisions of section 11,12,13 of the Income Tax Act, 1961.

To apply and use the funds for all or any of the objects of the Trust and to accumulate the surplus and unapplied portion of the said income under "surplus account" and invest the same subject however to complying with the requirements of the Income Tax Act, 1961 as amended from time to time relating to accumulation of Income and Investment thereof.

The funds and Income of the Trust shall be solely used towards the achievements of the object and no portion of it shall be utilized for the payment of the Trustees by way of profit/dividends etc.

**19. POWER TO REMOVE THE TRUSTEES:**

Where a Trustee becomes insolvent or is convicted for an offence by a court of law, excepting in the cases where he is acting in a judicial capacity or if in the opinion of Board of Trustees the concerned Trustees has been detrimental to the interest of the Trust, such Trustee shall tender his resignation and if he does not do so within reasonable time, the Trustee shall have the power to remove him from the Board of Trustees by 2/3<sup>rd</sup> majority. Any member of the Board may resign for personal reasons, such members shall cease to be the Trustee upon the acceptance of his/her resignation.

**20. AMENDMENT CLAUSE:**

The Trustees shall have powers to alter or amend provisions of this deed and frame such bye-laws subsidiary rules and regulations and shall have further power to add or amend the same from time to time as may be necessary for the conduct of their business provided that the rules and regulations so framed and amendments so effected are not inconsistent with the objects of the Trust and also to provisions of section 11,12, 13 and 80(G) of the Income Tax Act, 1961 governing Charitable Trusts.

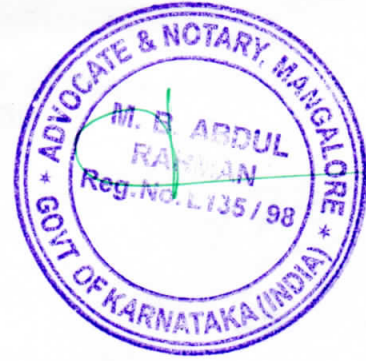
**22. POWER TO DISSOLVE THE TRUST**

NOW, THEREFORE, this SUPPLEMENTAL DEED OF TRUST is executed and witnesseth as follows:-




1. That Clause No.(7) of the Principal Trust Deed dated 25-07-2005 is hereby deleted and the same is substituted by the following clause:-

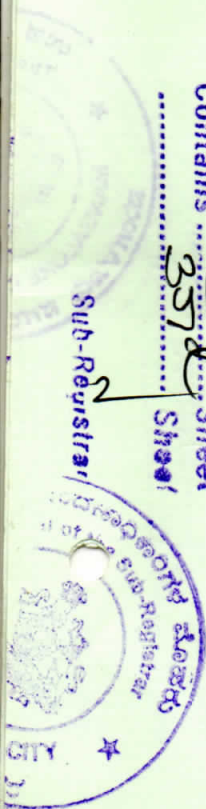

2. Powers of the Chairman:-



purpose to sign and execute the necessary applications, deeds forms, bonds or do whatever that is required to be done so as to run, open and manage the educational institutions. However, for all such acts, deeds and things the Chairman shall obtain prior approval of the Board of Trustees.

3. Bank Accounts

The Chairman Dr.Fakhruddin Kunil and General Secretary Mr.Mohammed Hanif Adka jointly shall have all the powers to operate the existing Bank / Banks Accounts of the Trust and open new Bank Accounts at any branches of the Nationalised Banks. All the cheques to be drawn in the name of the Trust shall henceforth be drawn/ signed by Dr.Fakhruddin Kunil, the Chairman and Mr.Mohammed Hanif Adka, the General Secretary of the Trust.

4. Remuneration of the Trustees:-

None of the Trustees is entitled to any remuneration from the Trust.

5. The Chairman shall preside over all the Board meeting of the Trust. However for any reasons if the Chairman is not available or remains absent, the Vice Chairman shall preside over the Trust meeting.

6. The term for the trustees No.(1) to (5) will be the Trustees for life with their respective post of office bearers. However, they, shall during their life time itself nominate one of their legalheirs/legal representatives as Trustee to be appointed in their respective place after their death. The said nominated Trustees shall have the same right as his/her predecessor are entitled to. All other future nominated/appointed Trustees shall have no right to nominate. However, the Trustee No.(1) hereby nominate his son Mr.Najeeb Kunil as Trustee in the event of death / resignation of the Trustee No.(1). So also Trustee No.(2) hereby nominate her daughter Mrs.Natasha Baig as Trustee in the event of death / resignation of the Trustee No.(2).

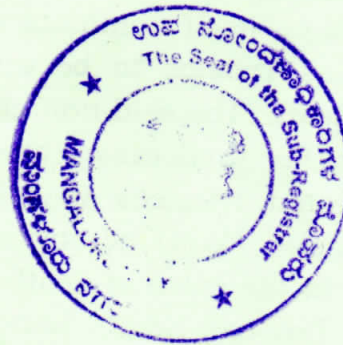

7. In the event of the aforesaid Trustees namely Trustees No.(1) to (5) dies without any nomination, the senior most member among their legal heirs shall be admitted as Trustee in the place of the deceased Trustee/s. However, the eldest member of their family express his/her unwillingness to be a trustee, the second eldest member shall have right to be trustee of the Trust. The said Trustees shall have the same right as his/her predecessor are entitled to.
8. In case of any disputes regarding implementation, execution or interpretation of the Supplemental Deeds or of the original Trust Deed, that may arises among the Trustees, the same shall be resolved by a sole arbitrator appointed by the Trustee No.(1) to (5), under the provisions of Arbitration and Conciliation Act, 1996 and the decision of the Arbitrator shall be final and binding on all the parties.
9. In all other aspects the clauses in the original Trust Deed dated 25-07-2005 shall remain in full force with all its effects.
